Quotation or pro-forma invoice has to be provided prior to delivery/installation of eligible energy and resource efficiency equipment/materials. The quotation must contain at least the following information:

- date, name, address, legal registration of the eligible supplier/installer;
- technical specifications and details of the eligible equipment to be supplied/installed in accordance to the technical performance criteria as listed in the Business Window LEME of KyrSEFF;
- binding offer for the kinds and quantities of equipment/materials, including price;
- address of place/ facility where such Project will be installed; name, address and telephone of applicant.

B) In case that

- the planned equipment is not included in the LEME of the KyrSEFF Business window

Quotation or pro-forma invoice has to be provided prior to delivery/installation of eligible energy efficiency /water/ resource efficiency equipment/materials. In addition to the above listed information, the quotation must contain at least the following information:

- technical specifications and details of the equipment to be supplied/installed as listed in the categories of the KyrSEFF LEME Business Window;
- Brief description of the technical parameters of the existing equipment/machinery (e.g. operation mode/ hours, capacities, types and amounts of energy used).

In case the equipment supplier is not providing installation services the following information about the intended installation company need to be submitted: name, address, legal registration.

C) In case that the

- investment costs are above USD 300,000

- Energy consumption of existing equipment/machinery (e.g. operation mode / hours, capacities, types and amounts of energy used);
- Project planning documents (e.g. specification of energy saving techniques, equipment and their capacities);
- Offers from equipment suppliers, if available.

For complex projects, detailed designs/conceptual designs/energy assessment and technical specifications form part of the quotation and shall be read in conjunction therewith.
